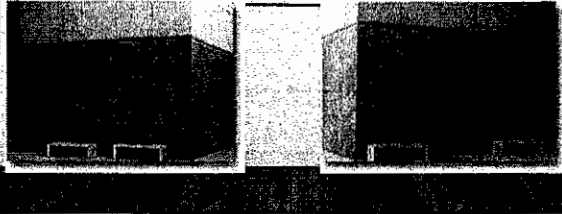

WHAT IS THE LEGISLATURE?

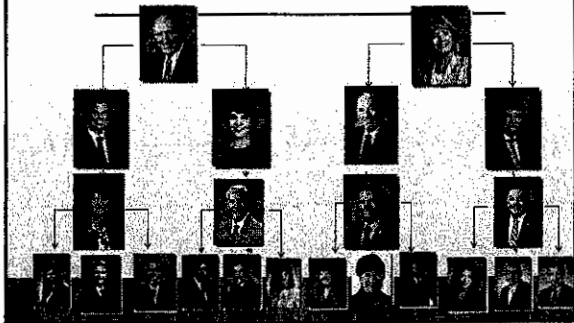
- State level lawmaking
- State budget
- Consists of the House of Representatives and the Senate

WHO ARE YOUR LEGISLATORS?

- "Citizen Legislature"
 - "Qualified elector"
 - At least 25 years old
 - State/County residency
- Elected every two years
- Range in occupation/education/life experience

Committee Of the Whole



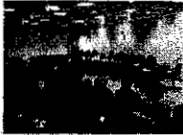
- Open debate
- Adoption of Amendments
- Voice vote

Third Reading of Bills



- Vote of entire chamber
- Need 31 or 16 votes total

GOVERNMENT AFFAIRS GROUP



WHAT DOES THE GOVERNMENT AFFAIRS GROUP DO?

- Staff proposals through the Arizona Judicial Council subcommittee process
 - Lobby as directed by the AJC
 - Maintain values set by AJC at Capitol
 - Interface between the Legislature and Judiciary
 - Work with stakeholders to find solutions

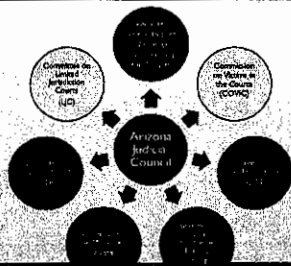
ARIZONA JUDICIAL COUNCIL

• Assists the Supreme Court and the Chief Justice in development /implementation of policies and procedures for:

- the administration of all courts
 - uniformity in court operations, and
 - coordination of court services that will improve the administration of justice in the state of Arizona
- Chaired by the Chief Justice (Scott Bales)

WHAT IS LOBBYING?

• Attempting to influence the passage or defeat of legislation by directly communicating with any legislator

• Private lobbyists

- Contract
- In-House

• Public Liaisons

- Agency
- Political subdivisions

WHAT IS THE AJC PROCESS?

- Identify issues that may require legislation
- Review pending legislation
- Provide direction to AOC Gov Group
- Implementation

TYPES OF ISSUES

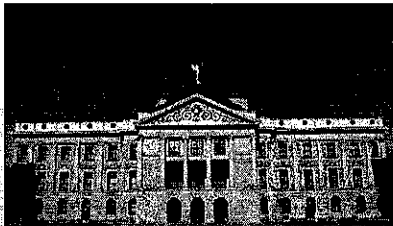
Policy
